They also attend a group ALA webinar "A step-By-Step Guide to Hybrid Programming. In May Jennifer also attended a conference by the NYLA Section of School Librarians and went to workshops on Book Challenges, Refining Your Collection Development Policy, Using Social Media and Leadership. The summer reading program is underway for both children and adults. The adult program is being run through READsquared. Jennifer is starting a new book club called Second Look for people who want to read beyond the bestsellers list. Between the Lines Book Club continues to meet on the fourth Monday of each month. In July we will have a
